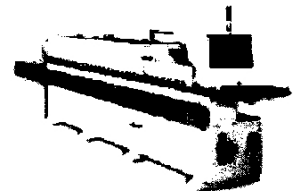
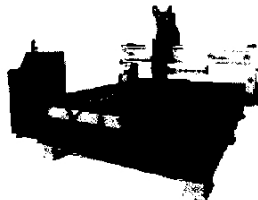
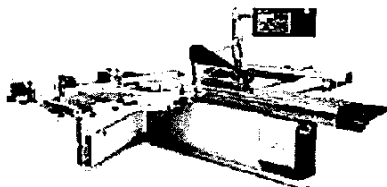
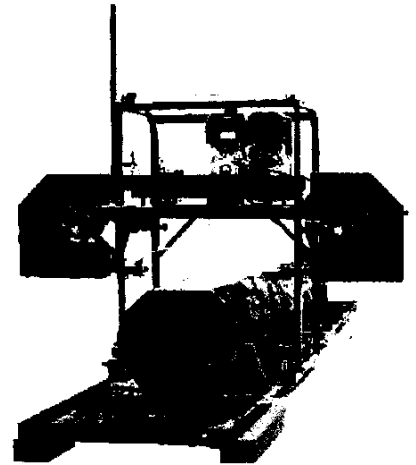
WOOD INDUSTRY IN KENYA & EAST AFRICA

- + The east African economies consume US \$1.2 billion worth of furniture annually, of which 22 percent is imported. Since growth is driven by growing urban populations and purchasing power, growth prospects are favourable, and Kenya, Ethiopia, Tanzania and Uganda are likely to remain the dominant furniture markets.
- + Kenya is the largest market for furniture in east Africa. It is also the largest producer of furniture manufacturing twice as much as Ethiopia, the next biggest market.
- + Kenya is a Largest market for Particle board, Gypsum board, MDF board & Plywood.
- + The demand of furniture has been growing some 10% per year.
- + Kenya and East Africa has a very big market for laminate products.
- + In Kenya plywood mills consume 15 percent of industrial wood available for furniture, and they produce plywood, MDF, particle board, block board, and veneer. These mills sell predominantly to the formal industry and use pine and cypress as raw material, with knots and timber structure limiting the visual quality of plywood.
- + Kenya emerged the third most preferred real estate investment destination globally for the super-rich after the UK and US in a study that also shows that nearly a quarter of Africa's rich have property locally.
- + Important aspect of Kenya's wood processing sector are wood carvings, which is estimated to utilize 600 tonnes of wood annually.





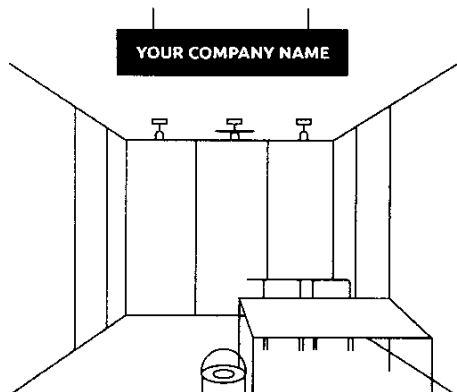
- ✦ The last five years has seen tremendous growth in the wood flooring sector as many move from the conventional tiles to wood blocks.
- ✦ There is growing optimism in the future performance of the wood coatings market as Kenya revives the stalled plans for the construction of two million additional housing units across the country's urban areas with first 500,000 housing units expected by 2022.
- ✦ The industry produces approximately Kshs 4.5 billion of furniture per year and exports Kshs 0.2 billion. The sector contributes about 5% to the country's GDP.



STALL PARTICIPATION COST

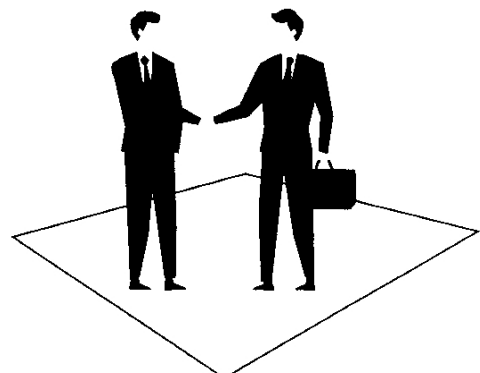
Standard Stand Construction

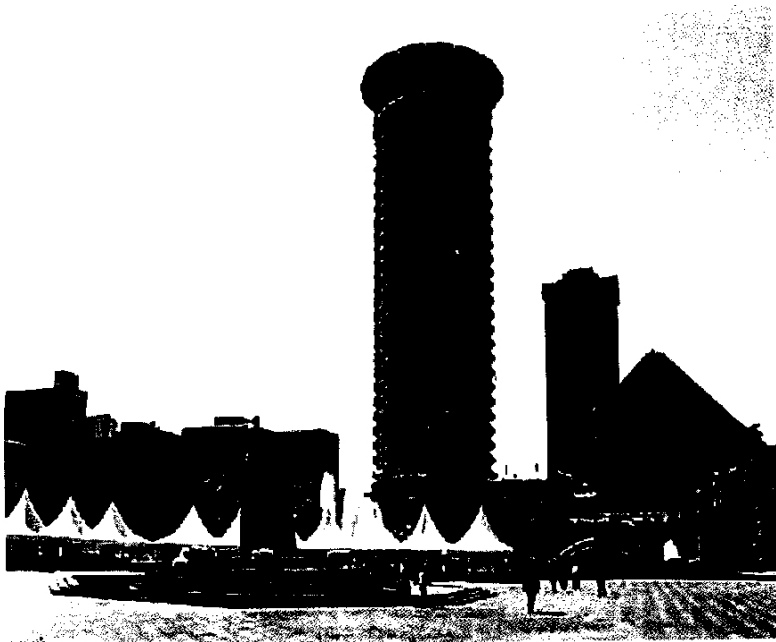

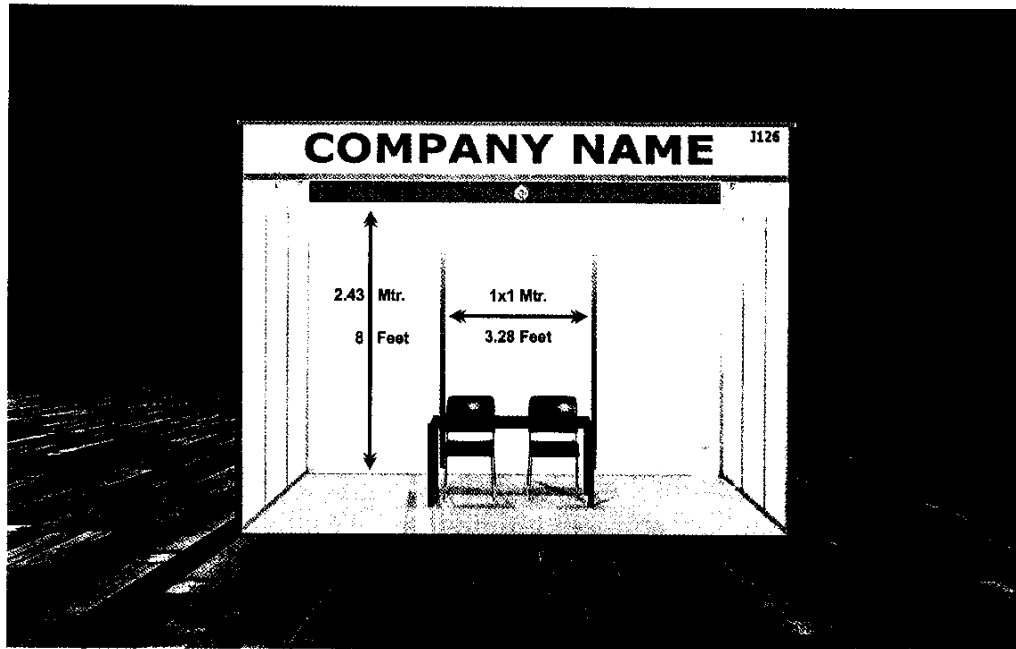

RULES & REGULATIONS: -

1. Registration through this form is binding.
2. The Exhibition Regulations are integrally part of this binding registration form. A selection of the most important regulations is to be found herein

TERMS OF REFERENCE:

In these Rules and Regulations, the Term 'Exhibitor' shall include all employees, staff and agents of any company, partnership firm or individual to whom space has been allocated for the purpose of participating. The term 'producers' shall mean Radeecal Communications having registered head office at Ahmedabad, Gujarat.

RIGHTS:

The producers reserve all rights in connection with the exhibition.

ALLOTMENT:

- A. Booth will be allotted on a first-come-first serve basis.
- B. Allotment of booth(s) will be made at the sole discretion of the producers.
- C. The booth(s) allotted will be used solely by the participants for display of goods noted in their application form. Sub-letting of booth(s) or displaying goods not covered by the original application will not be allowed.

STAND ALTERATION:

- A. No alteration to the size or position of an Exhibitor's stand is permitted without the prior written approval of producers.
- B. The producers reserve the right to modify the layout of booth sites and gangways.
- C. The producers reserve the right to require Exhibitors to make such alterations to their booths, as to the setting of exhibits as they reasonably feel necessary to maintain an acceptable standard of presentation or to avoid interference with the displays of other Exhibitors.
- D. Conversion of an allocated shell scheme site, to free design is not permitted.
- E. While reasonable fixings may be made to the flush plywood walls of the shell scheme, no alterations to the fascia structure or the format is permitted. Any attempt to do this will involve the re-installation of the original structure at the expense of the Exhibitor or his agent.
- F. Booths may not overhand the allotted area, nor are any obstructions permitted on gangways, fire points, extinguishers, or emergency exits.
- G. Designers are particularly requested to avoid design which block or box in other Exhibitor booths.

BOOTH INTERIORS:

- A. While the exhibitors are free to decorate their booths to the best of their ability for projecting the right image for their products and company, they should not cause any permanent damage to the walls, panels and floors through use of nails, paintings or any other such activity.
- B. Permitted Height for Prefabricated (constructed) stall is 8Ft for Walls.
- C. Any Prefabricated Stall Facia Branding above 8Ft – Take necessary approvals from organizers side in writing or via E-mail.

PAYMENT DETAILS:

100% participation charges on Stall Booking

CANCELLATION CHARGES:

50% of total participation charges will be considered as a forfeiture amount, if cancellation is done before 90 days of exhibition date. For any cancellation thereafter, 100% participation charges will be considered as forfeiture amount.

Force Majeure:

No party to this agreement shall be liable to the other party for any failure of or delay in performance of its obligations hereof or be deemed to be in breach of this agreement, if such failure or delay has arisen from force majeure such as earthquake, typhoon, flood, fire and war and other unforeseen events, and their happening and consequences are unpreventable and unavoidable. The party who is prevented or delayed from or in performing any of his obligations under the agreement by force majeure shall notify the other party without any delay, and within 15 days thereafter provide the detailed information of the events and a valid document for evidence issued by the relevant public notary organization for explaining the reason of its inability to execute or delay the execution of all or part of the agreement. Both parties shall, through consultations, decide whether to terminate the agreement or to exempt the part of obligations for implementation of the agreement or whether to delay the execution of the agreement according to the effects of the events on the performance of the agreement.

If any epidemic situation (like COVID 2019) if the event is postponed then all the advance payment will be consider in the future events.

INSURANCE:

- A. Insurance of the exhibits and the property of the booth will be responsibility of the individual Exhibitors.
- B. The producers shall not be responsible in any way for personal injury to the exhibitor or his staff, agents, invitees or licensees, however caused.

CONSEQUENTIAL LOSS:

In case of the show being cancelled or suspended in whole or in part for causes not in the producer's control, the producers do not accept any consequential liability in any such eventuality.

DEFAULT ON PAYMENTS:

The producers reserve the right to cancel any reservation of space in the event of an Exhibitor not having paid the dues of rental charges as stipulated on the rate card.

SPACE NOT OCCUPIED:

- A. Every exhibitor shall occupy the full stand area booked by him.
- B. Should an Exhibitor fail to take up the stand allocated to him, the producers reserve the right to deal with the booth so unoccupied as they think fit.

NO SUB-LETTING:

The exhibitors may not assign, sublet or grant licenses in respect of the whole or any part of the booth. Cards, advertisement or printed matter of persons or firms who are not bonafide exhibitors will not be exhibited or distributed from any booth except that an exhibitor may distribute cards, advertisements or printed matter in respect of companies or firms which are subsides of exhibitor or the exhibitor's ultimate holding company.

SECURITY:

Although a twenty-four-hour security service will be in operation throughout the show, Exhibitors should take all possible precautions to minimize loss or damage to the equipment outside of show open hours.

FAILURE OF SERVICE:

The producers will use their best endeavors to ensure supply of services of the official contractors, but as the supply of such services are not within the contractors, neither they nor the producers shall incur any liability to the exhibitor for any loss or damage, if any such service shall wholly or partially fail or cease to be available. Nor shall the exhibitor be entitled to any allowance in respect of rental due or paid under the contract.

LIABILITY:

The Company, its directors, officials, employees and office holders or its agents, will not be liable in any way for any injury, theft, damage, loss or harm of any kind whatsoever or which occurs as a result of any reason whatsoever that may be caused to person or property while they are present on the area of the exhibition grounds. And no compensation will be provided for damages due to theft, lighting fire, explosion or rainwater. The company will not be liable for any losses whatsoever that may be caused to the exhibitors in the event that water or electricity is cutoff or in case of any natural calamity.

ELECTRICAL INSTALLATION:

All on-site electrical installation must be carried out by the officially appointed electrical contractor before the connection to the mains supply.

JURISDICTION:
